How can acknowledgement be done?

- Cairn/plaques with CRT history set up in town and in high use areas (e.g. cenotaphs to soldiers)
 - At museums
 - o Waldo historical gazebo
 - Baynes Lake church (moved from Waldo) with historical display
 - Shelter Bay boat launch
- Most losses cannot be replaced
- Limited resident knowledge now
- Needs to be something that lasts
 - videos with stories by impacted families
 - Need to reach out to (involve?) the Province that benefits
- Something at Visitor Centres
- Call the waterbodies "reservoirs" not "lakes"
- Do something like the Grand Coulee light show story??
- Something at provincial parks on reservoirs story telling, interpretation
- Williston First Nations displacement recognition
- Geographical info systems show reservoirs at empty and full
- Include First Nation history
- First, tell the stories of physical displacements and economic change in a way that is easily accessible to the public e.g. online and at community locations

Who does the acknowledgement need to come from?

- BC Hydro
- Federal and Provincial governments they made the decision

Other Comments

- Lots of history is out there not collected, not user friendly
 - Columbia Basin Trust has many resources https://thebasin.ourtrust.org/columbia-river-treaty/resources/
- Augmented reality showing before and after the reservoir
- Apology from government of Canada (BC government, BC Hydro) in bronze on concrete
 - Acknowledge lack of consultation
 - o Implications for the Sinixt
 - Expropriation practices
 - Compensation amounts
 - Was a traumatic incident for those involved
- Get story in schools
- First Nations loss of cultural sites and loss of use/opportunities

How can acknowledgement be done?

- More than talk
- Sharing stories
 - Allocate resources to record and share stories
 - Money directly to communities for their own studies
- Help youth be involved; educate the youth; 7 generations
- Financial support to implement /develop agriculture and other opportunities
 - Food security
- Bring salmon back make that a priority and acknowledge the challenges: work toward it anyway and understand why they were lost in the first place
- Understand and support the full cycle of life

What was lost?

Losses to acknowledge – educational, recreational, logging, cultural/lands etc.

How can acknowledgement be done?

- Golden Documentary for wide public viewing (government sponsored)
 - Suitable caliber of production (Planet Earth quality) to show at places like Banff
 Film Festival, PBS, Netflix, Sundance Festival
 - Nelson has video available at the museum
 - For future generations
 - o Government have acknowledgement of these losses in the video

- Castlegar remind people of the benefits, programming etc that CBT supplies
 - CBT successes symposium's all-inclusive ideas and follow-up with actions when possible
 - Could ask for a broader Affected Area Program
- Take video footage of Global Affairs when they visit the Basin
- Outside of CBT funding monies derived for benefits to BC is it seen as part of acknowledgement?
 - Equalize monies received between communities in the Basin. Now inequities in compensation from Grants in Lieu (GILT). Most recent look at GILT was the George Penfold Report 10 years ago
- Do Columbia River tour (Full Basin) via signage
 - To educated and acknowledge areas and scope of losses
 - Pinpoint each area with a major loss to that area
 - To draw a vignette of the effects of Columbia River Treaty Dams to communities and First Nations
 - Put these at boat launches, community information centres, parks
- Rural Development Institute could be involved

Who does the acknowledgement need to come from?

- What is the tone of the acknowledgement? Negative? Positive? How to regulate this?
 - o In the 1950s we didn't think of that, now we must go forward
